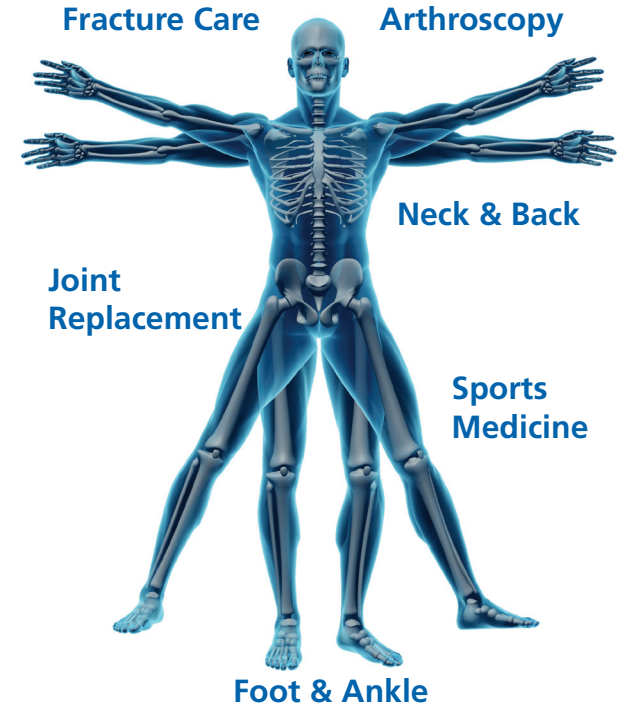
CURTIS C. PEDERSEN, DPM

SPORTS MEDICINE

Great teams come together! Intermountain Healthcare is the official sports medicine provider for athletes at Utah State University and Cache Valley High Schools. Canyon View Orthopedics is part of the Intermountain Sports Medicine team. Our orthopedic and sports medicine specialists work closely with physical therapists, certified athletic trainers, and other physicians to provide a full spectrum of sports medicine services. Our program includes Acceleration, the only nationally recognized sports enhancement program offered locally.

OFFICE HOURS AND PHONE CALLS

Office hours are 9 a.m. to 5 p.m., Monday through Friday. During regular office hours, call 435.716.2800 for medical questions, appointments, or billing inquiries. Our staff, including our billing department, is skilled in answering your questions. They will handle your needs immediately, or call you back quickly — usually within an hour. Advice given by the staff will reflect the professional philosophy of the physicians, but you will always have the option of making an appointment. When the office is closed, you may reach the physician on call for emergencies 24 hours a day by calling 435.716.1000.

APPOINTMENTS

Patients are usually seen by appointment, scheduled for the earliest available time with your physician. Same-day appointments are often available for injuries and other urgent needs. In case of serious medical emergencies, go directly to the Logan Regional Hospital Emergency Department.

If you need to cancel an appointment, please try to call the office at least 24 hours in advance so your appointment time can be made available to someone else. Also let us know if you will be late for an appointment. Whenever possible, we will alert you if we are delayed or unexpectedly unavailable. It is always wise to call before you leave home, to see if our scheduled appointments are running on time.

PHYSICIAN COORDINATION

Our orthopedic and sports medicine physicians work closely with your primary care physician and other appropriate healthcare providers before, during, and after treatment or surgery. We communicate clearly with your physician to help make sure all your healthcare needs are met. Your healthcare is a team effort between you, your orthopedic specialist, and other physicians providing your care.

BILLING

Except for hospital and emergency care, we require payment when services are rendered. We accept most health insurance plans, and we will bill your insurance company. Please pay copayments, coinsurance, and deductibles at the time of service. All returned checks incur a service charge.
